

COVID-19: Immigration Health Surcharge - Published 01 October

Arrangements have now been put in place for any non-EEA nationals applying for a health and care visa to work in a health and social care setting to not have to pay the Immigration Health Surcharge. UK Government - Local COVID-19 Alert levels

The new local COVID-19 alert levels have been introduced by the government to ensure the right levels of intervention are in the right places, in order to manage any outbreaks. Depending on the area where you live, work or travel to, this will determine what you can and cannot do.

An overview of some of the restrictions from each of the three alert levels are:

Local COVID-19 alert level: Medium

- You must not socialise in groups larger than 6, indoors or outdoors
- Face coverings must be worn where mandatory
- Social distancing rules must be followed
- You must work from home where you can
- When travelling, plan ahead and avoid busy times. Walk and cycle where you can



Local COVID-19 alert level: High

In addition to those restrictions under the medium alert level, you must:

- Not socialise with anyone outside of your household or support bubble in any indoor setting (home or a public place)
- You must not socialise in groups of more than 6 outside, including in gardens

Local COVID-19 alert level: Very High

Restrictions may vary dependent upon discussions between central and local government, but could include the following:

- You must not socialise with anyone outside of your household or support bubble in any indoor setting, or in private gardens or outdoor hospitality settings
- You must not socialise in groups of more than 6 in outdoor public spaces
- You must aim to reduce the number of journeys made by travelling and avoid travelling outside of the area
- Avoid overnight stays in other parts of the UK

Policy Updates

In light of the recent government updates as detailed above, the Coronavirus Policy and Procedure has been updated to reflect the recent COVID-19 Alert Level guidance. All fact sheets and easy read documents have also been updated.
